Shri Ravi Shankar Prasad Hon'ble Union Minister Ministry of Communications & Information Technology Government of India

Ravi Shankar Prasad is an eminent lawyer and senior advocate in the Supreme Court of India. He has been a member of influential parliamentary committees such as Finance, Communications & IT, and Petroleum & Chemicals.

As a Cabinet Minister for Communications and IT, he has been spearheading the task of reviving India's telecom sector and also actively leading the initiative to make India a global electronics manufacturing hub. The flagship program of Digital India, which aims to bring about good governance by extensive use of information technology, is being implemented under his leadership. As an all-rounder in charge of the government's reform agenda, he is also overseeing the reforms in the Indian legal and judicial system.



HE Dr S. Jaishankar

Indian Ambassador to the United States


Dr S. Jaishankar assumed his responsibilities as ambassador of India to the United States in December 2013. He arrived in Washington DC with more than three decades of diplomatic experience, having joined the Indian Foreign Service in 1977 and represented India's interests and fostered friendly working relationships in countries around the world. Dr Jaishankar's first postings abroad were as Third and Second Secretary (Political) at the Embassy of India in Moscow from 1979 to 1981. From 1981 to 1985, he served as Under Secretary (Americas) and Policy Planning in the Ministry of External Affairs. He then spent three years from 1985 to 1988 as First Secretary handling political affairs at the Indian Embassy in Washington, DC, followed by two years as First Secretary and Political Advisor to the Indian Peace Keeping Force (IPKF) in Sri Lanka.

In 1990, Dr Jaishankar became Commercial Counsellor in Budapest. After three years in that position, he returned to India where he served first as Director of East Europe Division of the Ministry of External Affairs, and then as Press Secretary to the President of India. Following this service in India, Dr Jaishankar went abroad again - to Tokyo in 1996 as Deputy Chief of Mission.

In the year 2000, he was appointed the Ambassador of India to Czech Republic and served in Prague till 2004.

Dr Jaishankar holds a Ph.D. and M.Phil in International Relations and a M.A. in Political Science. He is also a member of the International Institute for Strategic Studies in London.





Before his posting with UIDAI, he worked with the Government of Jharkhand as Principal Secretary of the Departments of Science and Technology, Drinking Water & Sanitation, Information Technology (IT), Rural Development and Human Resources Development. As Principal Secretary of the IT Department, he was responsible for the formulation of state policies in the IT and e-Governance areas. He also over-saw the implementation of various e-governance projects in all the departments of the state government. His contributions in the field of IT and e-governance have been widely recognised, both within India and outside.

Dr John P. Holdren Director, Office of Science & Technology Policy, The White House

John is assistant to the US President for Science and Technology in his role as director in the Office of Science & Technology Policy at the White House. He also co-chairs the President's Council of Advisors on Science and Technology (PCAST).

Prior to joining the Obama administration, Dr Holdren was Teresa and John Heinz Professor of Environmental Policy and Director of the Program on Science, Technology, and Public Policy at Harvard University's Kennedy School of Government, as well as professor at Harvard's Department of Earth and Planetary Sciences and Director of the independent, non-profit Woods Hole Research Center.

Previously he was on the faculty of the University of California, Berkeley, where he cofounded in 1973 and co-led until 1996 the interdisciplinary graduate-degree program in energy and resources.

During the Clinton administration, Dr Holdren served as a member of PCAST through both terms and in that capacity chaired studies requested by President Clinton on preventing theft of nuclear materials, disposition of surplus weapon plutonium, the prospects of fusion energy, U.S. energy R&D strategy, and international cooperation on energy-technology

Dr Holdren holds advanced degrees in aerospace engineering and theoretical plasma physics from MIT and Stanford.

Dr Rajendra Kumar is a senior officer in the Indian Administrative Service (I.A.S.) and is currently working as the Joint Secretary (e-Gov) in the Department of Electronics and Information Technology (DeiTY), Government of India.

He leads the entire e-governance and technology development for Indian languages initiative at the national level and is responsible for the overall implementation of the flagship National e-Governance Plan (NeGP) of the Government of India. He has conceptualized and implemented three major e-governance initiatives within DeiTY: the new Mobile Seva project aimed at bringing all government services on the mobile platform, EPramaan for electronic authentication of all users of egovernance services, and localization aimed at promoting the usage of Indian languages in e-governance and mobile based services. Prior to his current assignment, he has held senior positions in district administration and state government in Tamil Nadu.
