I am directed to invite kind attention to Cabinet Secretary's D.O. No. 082/2/4/2016-CA.IV dated 30.08.2017 (copy enclosed) requesting State Governments to consider formulating guidelines for providing preference to locally manufactured goods in public procurement in pursuance of Union Government's policy to provide preference to 'Make in India' in Public Procurement. [Refer to copy of "Public Procurement (Preference to Make in India) Order, 2017" (amended on 16.09.2020) enclosed herewith].

2. In this regard, I am directed to forward herewith a copy of grievance mail dated 17.01.2022 received from M/s TEMA alleging violation of Government of India's "Public Procurement (Preference to Make in India) Order, 2017" (PPP-MII Order) revised on 16.09.2020 (Refer enclosure).

3. While the above Order is not applicable to the State Governments and its subordinate or attached offices. However, it is considered desirable to look into the interests of the Indian companies so as to give a boost to the domestic manufacturing.
