Subject: Non-compliance of PPP-MII Order, 2017 in the procurement of CCTV Cameras-reg.

The undersigned is directed to refer to meeting held under the Chairpersonship of Ms. Manmeet K. Nanda, Joint Secretary, DPIIT on 11.03.2022 on the subject matter(Copy of minutes attached).

During the meeting, representative from the Bureau of Indian Standards confirmed that **Indian standard IS: 13252** available for CCTV cameras is equivalent to UL/CE certification. It was decided in meeting that henceforth, all the procuring entities shall indicate BIS Standard only in the procurement of CCTV cameras.

In view of the above, it is requested to kindly issue suitable directions to concerned procuring entities to indicate the BIS standard (**Indian standard IS:13252**) only , in the procurement of CCTV cameras.
