This email is in reference to the Office Memorandum **F.No. 6/18/2019-PPD, notified by Department of Expenditure Public Procurement Division on 23<sup>rd</sup> July, 2020 for inserting Rule 144 (xi) in the General Financial Rules (GFRs), 2017 ("Notification")**

We wish to seek certain clarifications with respect to the Notification, we spoke to Mrs. Manmeet Nanda Madam on this and she guided us to reach out to you, we will be highly obliged if you could provide us with some directions on it:

Scenario – An Indian Company registered under the laws of India wishes to participate in a government tender. For fulfilling the order under the tender- this Indian company decides to procure certain raw material, components and finished goods from a Chinese supplier.

Would the Chinese company be required to register itself with the competent authority as per this Notification if the Indian company is procuring :

Scenario 1- only raw material from Chinese supplier?

Scenario 2- only components and subcomponents from Chinese supplier?

Scenario 3- finished goods from Chinese supplier?

We would be grateful to you if you could provide us guidance on the above issue.
