Notice for inviting Stakeholders' Comments

The Department of Telecommunications (DoT) proposes to review its PPP-MII order dated 21.10.2024, specifically the following aspects:

- a. List of products notified under the Order.
 - b. Product wise Local Content Requirement including the ceiling of LC for Design.
 - c. Conditions of inputs (including design) to be qualified as Local Content.
 - d. Criteria for calculating Local content for Software Products.
2. Multiple reports (NITI Aayog, TRAI, MAIT, PLI companies etc.) indicate that India's limited component ecosystem poses challenges in achieving 50-60% local content in electronic / telecom products. Recognizing this constraint, the conditions for local content qualification also requires a review.
3. Stakeholders are requested to provide their comments and suggestions on the above. Any recommendations for the inclusion of new products or exclusion of existing ones must be substantiated with detailed justification including verifiable data such as List of major manufacturers, Estimated local content value (%), Annual production capacity, Domestic sales & exports/imports (with figures), Sales to public sector entities etc.
4. The comments / suggestion if any may be furnished within 30 days of issue date of this notice. The comments are to be sent to email-id dirip.hq-dot@nic.in and usip.hq-dot@nic.in.
